### **Call for Papers (2nd notice) NAAHoLS at LSA**

The 2014 NAAHoLS meeting will again be held in conjunction with the Linguistic Society of America, the American Dialect Society, the Society for the Study of the Indigenous Languages of the Americas, and the Society for Pidgin and Creole Linguistics. Featured LSA plenary speakers this year include Susan Goldin-Meadow (U of Chicago) and Richard Larson (Stony Brook University).

The annual meeting will take place at the Minneapolis Hilton (1001 Marquette Avenue South) from 2-5 January, 2014. Further details about the meeting will be available in the coming months.

As in the past, we invite papers relating to any aspect of the history of the language sciences. All presenters must be members of the association (contact the NAAHoLS Secretary for details). Papers will be 20 minutes, with 10 minutes for discussion. Abstracts should be submitted as file attachments (MS Word). The length of the abstract should not exceed 500 words – upon acceptance, a shorter (100-word) abstract will also be requested for the meeting handbook. **The deadline for NAAHoLS abstracts is 1 September 2013.**

**24th International Colloquium of the SGdS**

**Potsdam, Germany (22-24 August 2013)**

The International Colloquium of the “Studienkreis ‘Geschichte der Sprachwissenschaft’” (SGdS) will take place at the University of Potsdam from August 22nd to August 24th 2013 under the following theme: *Metalinguistic Reflection and Discontinuity: Turning Points and Times of Crisis and Upheaval*.

The earlier call for papers (due 15 January) welcomed contributions that dealt with specific aspects of the relationship between metalinguistic reflection and discontinuity from antiquity to contemporary history. The papers will be presented in German or English, as well as in French, Spanish, or Italian. Notification of acceptance was to be sent to the authors by the end of January 2013. The conference fee will be 70 euros.

**13th International Conference on the History of Language Sciences**

**Vila Real, Portugal (25-29 August 2014)**

The 13th International Conference on the History of Language Sciences (ICHoLS XIII) will be held at the Centro de Estudos em Letras (CEL) of the Universidade de Trás-os-Montes e Alto Douro (UTAD), in Vila Real, Portugal, during 25-29 August 2014.

Papers relating to numerous aspects of the history of language sciences are anticipated, focusing on diverse topic areas ranging from antiquity to the contemporary history of linguistics and from individual case studies to methodological considerations.

The organizers had asked that proposals for papers be made in the form of abstracts of 400 words, including a few pertinent references, in an anonymous Word doc or rtf file accompanying the email communication and addressed to: **ichols-xiii@utad.pt**

The deadline for receipt of abstracts was July 15th, 2013, and final selection will be made by September 2013; notification of acceptance will be sent before December 1st, 2013.
